Chairman Maddalena gave a brief statement then introduced Catherine Hansford of Hansford Economic Consulting who presented the findings from the District's Impact Fee Study. Ms. Hansford reviewed the study findings, law and cost components, stating the fee methodology is typical and represents a buy-in fee of 12% share for new growth of the District's 20-year projected needs. She reviewed the annual CPI increase as well stating it would be applied using the cost index per the Engineering News Record and applied once approved by the BOS.

Chairman Maddalena and Ms. Hansford entertained questions from the BOS. Discussion followed with Public Works Director Tim Beals asking that members of the District Commission meet with his staff to address needed clarifications in the application of Appendix A prior to the BOS public hearing scheduled for October 20, 2020 at 1000. It was further stated that if a time crunch arises the public hearing can be rescheduled as needed. The updated fee structure will become effective 60 days after the BOS public hearing and approval. Discussion followed with Supervisor Roen stating he'd like to put a 5-year cap on the CPI increases as he is concerned those increases may prove cost prohibitive to new projects. Discussion will continue when this is presented after the public hearing tentatively scheduled for October 20, 2020.
